MALAYSIA'S TRADE PERFORMANCE, JUNE 2024

Malaysia's trade performance maintains positive in June 2024. Total trade recorded an increase of 8.7 per cent or RM19.0 billion to reach a value of RM237.8 billion as compared to RM218.8 billion in the previous year.

Imports remained a positive trend with an increase of 17.8 per cent or RM16.9 billion to RM111.8 billion. Concurrently, exports rose by 1.7 per cent or RM2.1 billion to RM126.0 billion. Trade balance recorded a surplus of RM14.3 billion, down by 50.8 per cent from RM29.1 billion in June 2023.

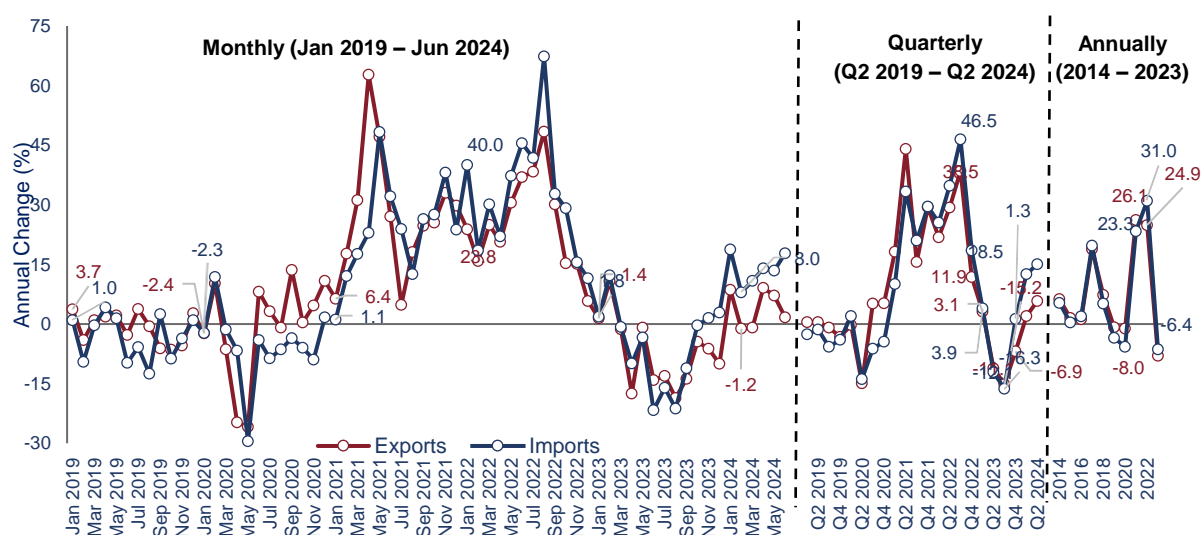
As compared to May 2024, exports, imports, and total trade recorded a negative growth of 1.6 per cent, 5.4 per cent and 3.4 per cent,

respectively, whereas trade surplus increased by 43.6 per cent.

For the second quarter (Q2) 2024, total trade, exports and imports also recorded an expansion as compared to Q2 2023 by 10.0 per cent, 5.8 per cent and 15.0 per cent, respectively. At the same time, trade surplus recorded a contraction of 42.7 per cent.

Exports, imports and total trade for first half of 2024 rose by 3.9 per cent, 13.8 per cent and 8.4 per cent, respectively, as compared to the same period of preceding year. Meanwhile, trade surplus declined by 44.5 per cent.

A. EXPORTS

Malaysia's exports increased by 1.7 per cent in June 2024

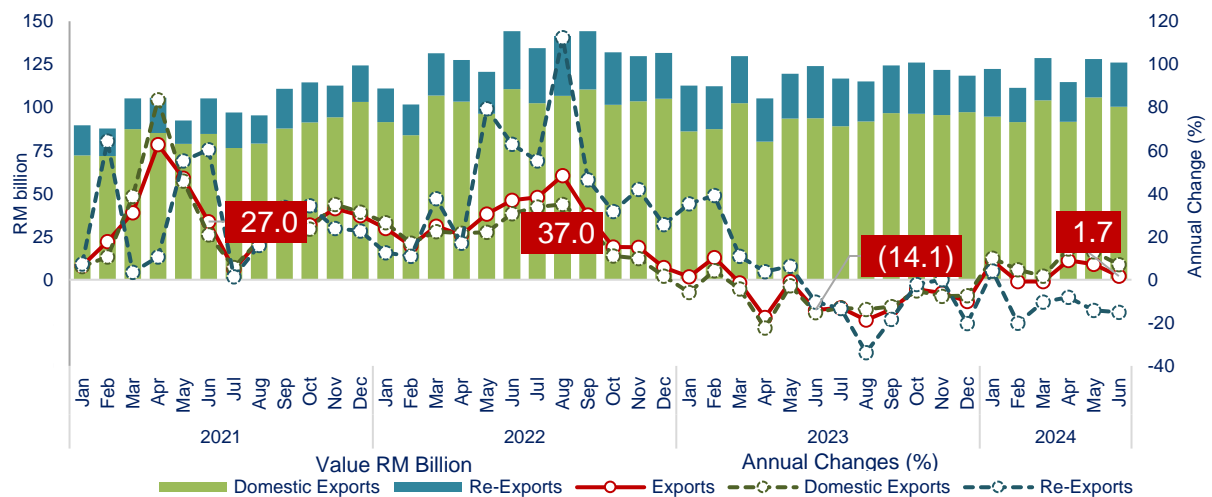
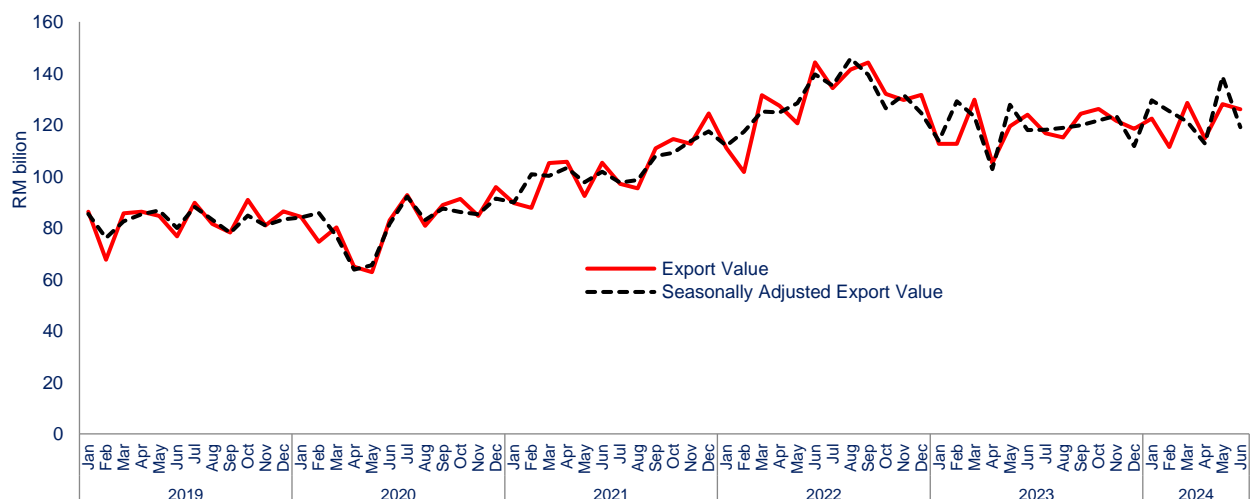
1. Performance of Exports

Malaysia's exports recorded an increase of 1.7 per cent as compared to the same month in 2023. Domestic exports, constituted 79.7 per cent of total exports, rose by 7.1 per cent from RM93.8 billion to RM100.4 billion.

However, re-exports which was valued at RM25.6 billion, comprised 20.3 per cent of

total exports, was down by 15.1 per cent from RM30.2 billion in the previous year. Moreover, a monthly comparison showed that exports fell by 1.6 per cent or RM2.0 billion. With regards to analysis of the seasonally adjusted terms month-on-month (m-o-m), exports decreased by 14.2 per cent to RM119.1 billion.

2. Export Performance for Major Country of Destination

Singapore and China were the main destination countries in June 2024 with a contribution of 29.2 per cent to Malaysia's total exports in June 2024.

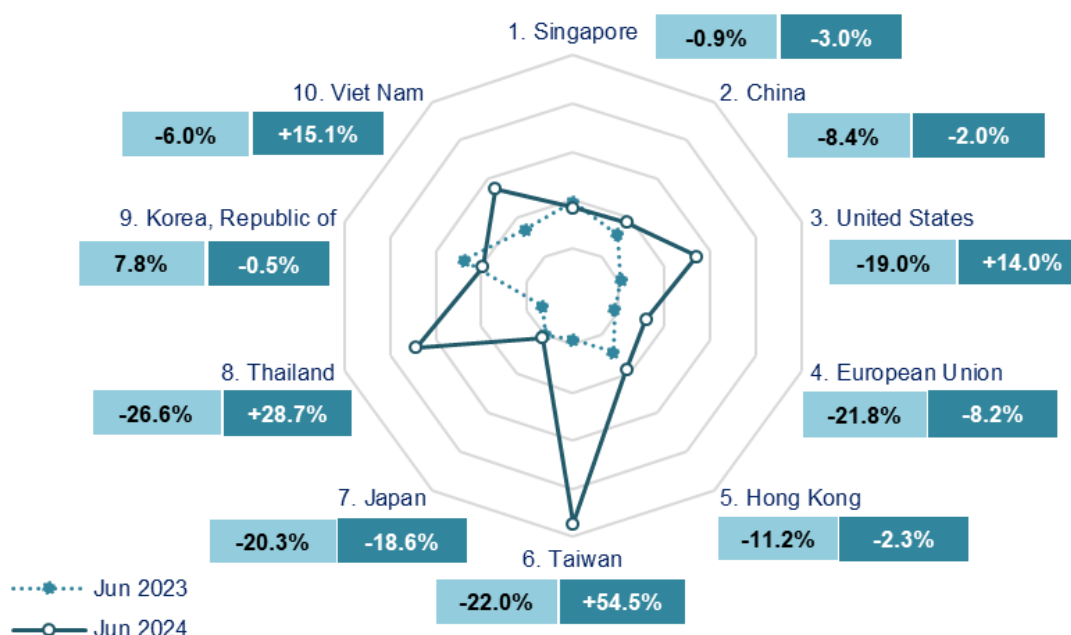
Singapore led the main destination countries with a contribution of 16.2 per cent to total exports. Exports to Singapore was valued at RM20.4 billion, declined by 3.0 per cent or RM642.1 million, year-on-year (y-o-y). The decrease was attributable from slower exports of electrical & electronic (E&E) products (-RM1.4 billion, -12.5%) and crude petroleum (-RM215.7 million, -83.5%).

Meanwhile, the value of exports to China (13.0 per cent of total exports), worth RM16.4 billion, decreased by RM342.3 million or 2.0 per cent. The decrease was supported by lower exports of E&E products (-RM546.0 million, -7.4%) and other manufactures (-RM224.3 million, -19.2%).

Out of ten major countries of destination, exports grew positively to the United States, Taiwan, Thailand and Viet Nam.

3. Exports to ASEAN Countries

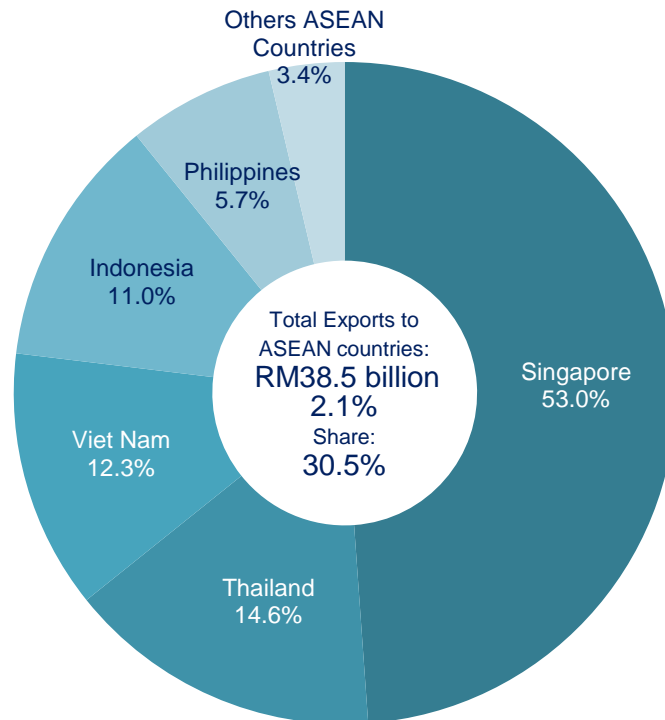
Exports to ASEAN countries constituted 30.5 per cent of Malaysia's total exports in June 2024. It was valued at RM38.5 billion, expanded by 2.1 per cent from RM37.7 billion in the same month of preceding year.

The rise was mainly impacted by the increase in liquified natural gas (+RM638.7 million,

+297.0%), crude petroleum (+RM534.5 million, +55.1%) and machinery, equipment & parts (+RM470.4 million, +23.0%).

Among ASEAN countries, Singapore was the main export destination with a contribution of 53.0 per cent, recorded a decrease of 3.0 per cent or RM642.1 million as compared to June 2023.

4. Export Performance for Economic Sectors

Exports of manufactured goods remained substantial to the total exports in June 2024 with a contribution of 87.1 per cent, recorded an increase of 1.0 per cent or RM1.0 billion to RM109.7 billion, y-o-y. The main contributors to the growth were machinery, equipment & parts (+RM1.1 billion, +25.1%), other manufactures (+RM941.1 million, +24.0%) and palm oil-based manufactured products (+RM461.5 million, +19.8%).

Likewise, mining products comprised 6.3 per cent of total exports, increased by 15.1 per cent from RM6.9 billion to

RM7.9 billion. The increase was in line with higher exports of liquefied natural gas (+RM877.8 million, +23.7%) and crude petroleum (+RM279.5 million, +15.4%).

Exports of agriculture products (6.1 per cent to total exports), recorded a growth of 1.7 per cent to RM7.6 billion. The increase was in line with higher exports of other agriculture (+RM141.6 million, +17.8%) and other vegetables oil (+RM100.1 million, +38.9%).

5. Exports of Selected Major Products

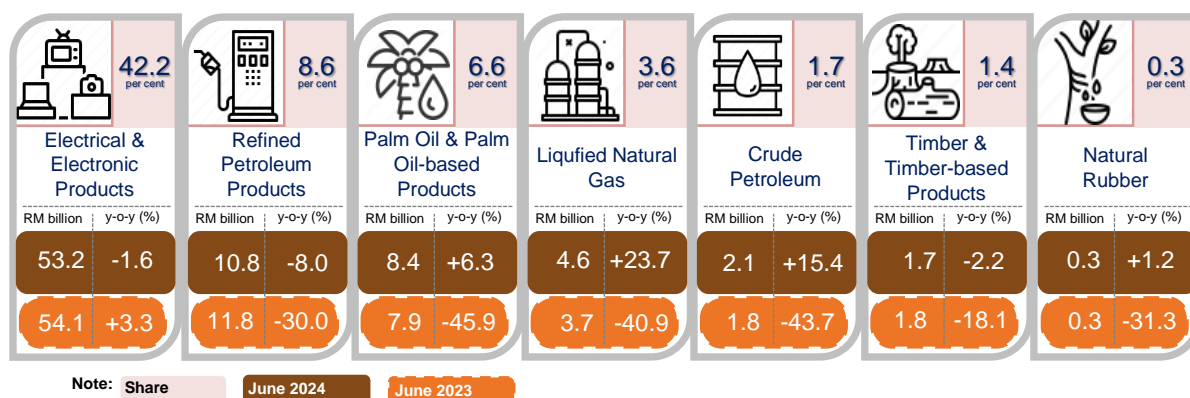
Export recorded a grew in June 2024, in line with positive growth by the following products:

- Liquefied natural gas, (3.6 per cent to total exports), was up by RM877.8 million or 23.7 per cent to RM4.6 billion, in line with the increase in export volume (+18.6%) and average unit value (+4.3%);
- Palm oil & palm oil-based products (6.6% of total exports), increased by RM498.3 million or 6.3 per cent to RM8.4 billion. Exports of palm oil, the main commodity in this product group, recorded a decrease of RM193.1 million (-4.2%), in line with the decrease in average unit value by 16.8 per cent. However, export volume was up by 15.2 per cent and domestic price for crude palm oil, rose by 12.3 per cent to RM3,957.5 per tonnes;
- Crude petroleum (1.7 per cent of total exports), elevated by RM279.5 million or 15.4 per cent to RM2.1 billion in line with the increase in average unit value by 16.7 per cent along with the increase in Brent oil price to RM388.8 per barrel. While, export volume decreased by 1.1 per cent; and
- Natural rubber (0.3 per cent of total exports), increased by 1.2 per cent or RM3.7 million to RM316.4 million. It was in line with the 24.2 per cent increase in average unit value and 34.1 per cent increase in rubber prices (SMR20). However, contraction was recorded for export volume by 18.5 per cent.

However, negative growth was recorded for following products:

- Refined petroleum products, representing 8.6 per cent of total exports, reduced by RM934.6 million or 8.0 per cent to RM10.8 billion in line with the decline in export volume (-19.6%), however average unit value increased (+14.5%);
- E&E products, contributing 42.2 per cent to total exports, decreased by RM868.2 million or 1.6 per cent to RM53.2 billion; and
- Timber & timber-based products decreased by 2.2 per cent or RM38.2 million to RM1.7 billion, contributing 1.4 per cent to total exports.

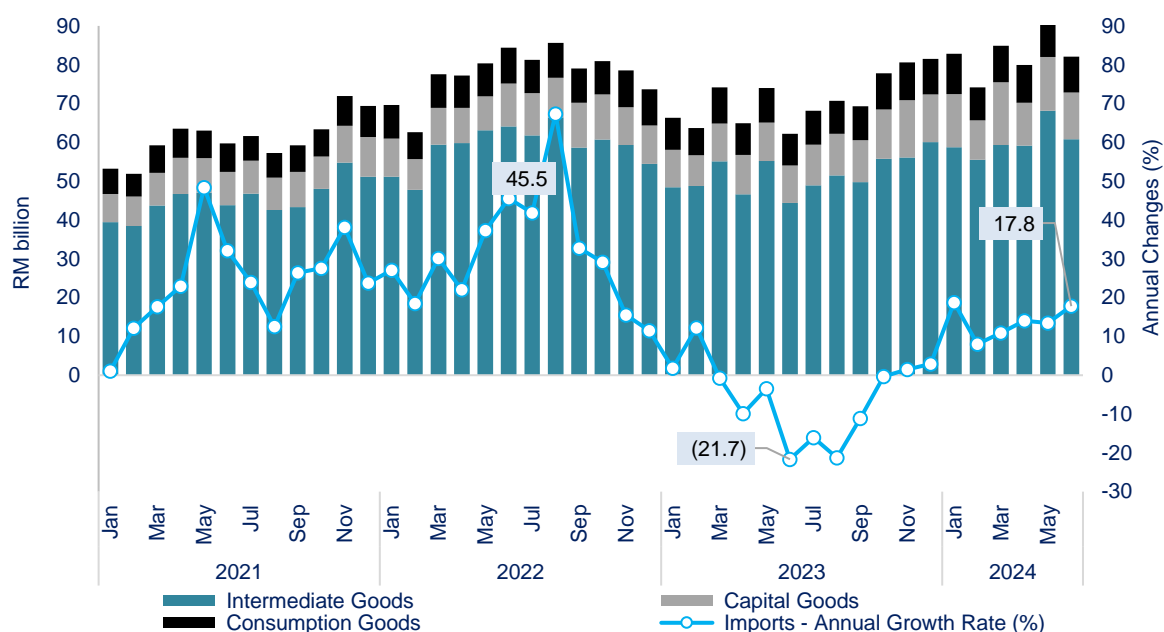
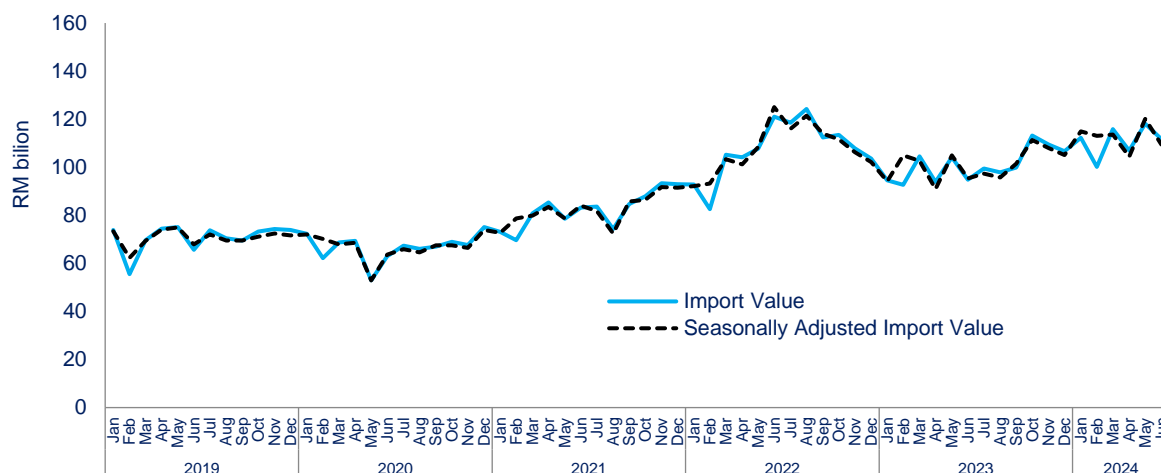
Exhibit 2 Exports of Selected Major Product, June 2023 dan June 2024



B. IMPORTS**Imports continued to expand 17.8 per cent in June 2024****1. Performance of Imports**

Malaysia's imports in June 2024 continued to grow by 17.8 per cent or RM16.9 billion, to post a value of RM111.8 billion as compared to June 2023. As compared to May 2024, imports subdued by 5.4 per cent or RM6.3 billion. Analysis in seasonally adjusted terms, m-o-m, imports also fell by 8.8 per cent to RM109.5 billion.

On a y-o-y basis, imports by End Use recorded an increase for all three major categories. Imports of intermediate goods rose RM16.5 billion (+37.2%), followed by an increase in capital goods of RM2.3 billion (+23.5%) and consumption goods of RM1.1 billion (+13.5%).

2. Import Performance for Major Country of Origin

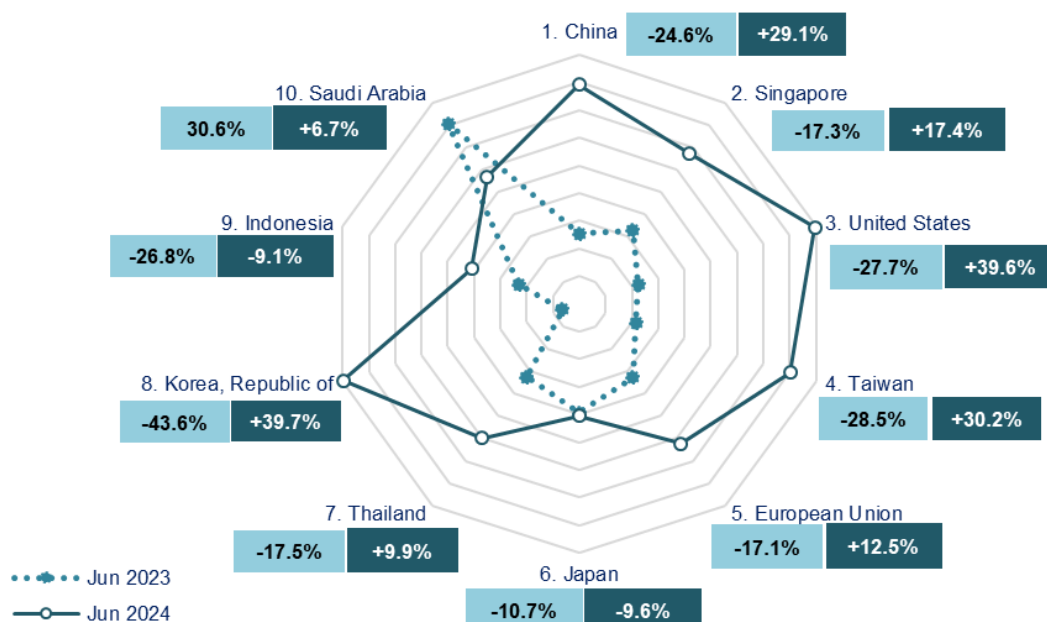
China and Singapore remained as the two major countries of origin for Malaysia's imports in June 2024, with a contribution of 34.5 per cent to total imports.

Imports from China represented 22.1 per cent of Malaysia's total imports, increased by 29.1 per cent from the recent year to RM24.7 billion. The rise in imports from China was driven by an increase in E&E products (+RM3.6 billion, +52.0%), followed by machinery, equipment & parts (+RM490.9 million, +19.7%) and transport equipment (+RM331.5 million, +49.9%).

Imports from Singapore was worth RM13.8 billion, accounting for 12.4 per cent of Malaysia's total imports, an increase of 17.4 per cent or RM2.0 billion, y-o-y. The increase was driven by E&E products (+RM866.6 million, +21.7%) and petroleum products (+RM662.6 million, +19.8%).

The annual change in imports from two major countries of origin recorded a decrease as compared to the same period last year. Concurrently, positive growth was recorded from China, Singapore, the United States, Taiwan, the European Union, Thailand, Republic of Korea and Saudi Arabia.

3. Imports from ASEAN Countries

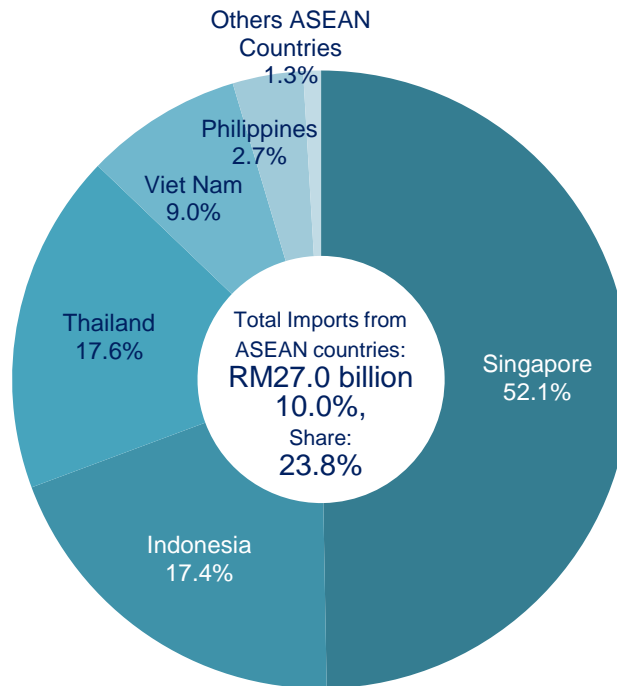
Imports from ASEAN countries recorded a 10.0 per cent increase in June 2024 to RM26.6 billion as against RM24.1 billion in June 2023 and accounted for 23.8 per cent of Malaysia's total imports.

This increment was mainly attributable from higher imports of petroleum products (+RM1.1 billion, +28.6%), E&E products

(+RM937.9 million, +15.1%) and manufacture of metal (+RM328.5 million, +55.2%).

Among ASEAN countries, 52.1 per cent of imports was from Singapore, an increase of 17.4 per cent or RM2.0 billion as compared to the previous year



Chart 9 Percentage Share of Imports from ASEAN Countries, June 2024

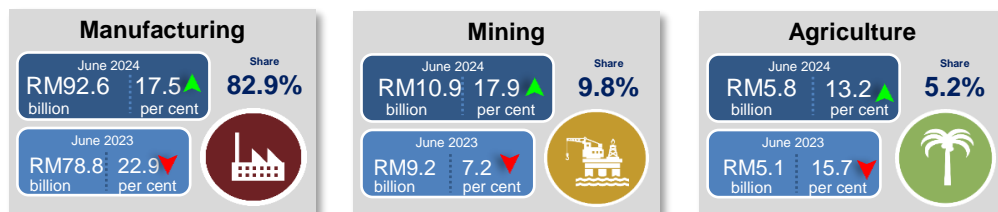
4. Import Performance for Economic Sectors

Imports of manufactured products (82.9 per cent of total imports), elevated by 17.5 per cent from RM78.8 billion to RM92.6 billion, y-o-y. This performance was driven by higher imports of E&E products (+RM8.9 billion, +33.0%), machinery, equipment & parts (+RM1.9 billion, +26.5%) and petroleum products (+RM760.5 million, +7.5%).

Mining products (9.8% of total imports) amounting to RM10.9 billion, uplifted by 17.9 per cent or RM1.7 billion as compared

to the previous year. It was driven by higher imports of crude petroleum (+RM1.6 billion, +35.4%) and liquefied natural gas (+RM459.5 million, +65.6%).

Imports of agricultural products (5.2% of total imports) increased by 13.2 per cent or RM671.2 million to RM5.8 billion, supported by other agriculture (+RM829.6 million, +24.7%) and natural rubber (+RM177.7 million, +65.2%).

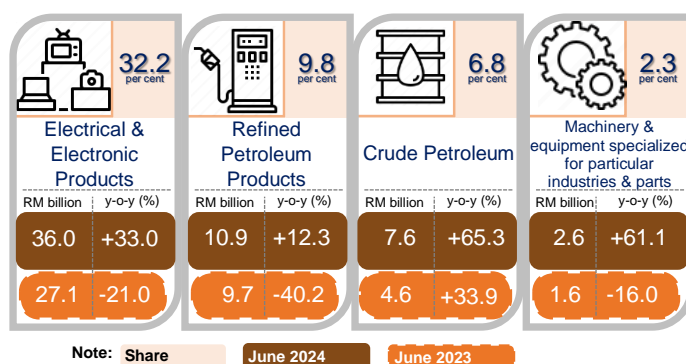
Exhibit 3 Imports by Sector, June 2023 dan June 2024

5. Imports of Selected Major Products

Imports showed a good performance in June 2024, with positive growth was seen in the following products:

- E&E products, contributing 32.2 per cent of total imports, increased RM8.9 billion or 33.0 per cent to RM36.0 billion;
- Crude petroleum, (6.8 per cent of total imports), was up by RM3.0 billion or 65.3 per cent to RM7.6 billion. It was in line with the grow in import volume (+44.3%) and average unit value (+14.5%) along with the 12.1 per cent rise in Brent oil prices to RM388.8 per barrel;
- Refined petroleum products (9.8 per cent of total imports), increased by RM1.2 billion or 12.3 per cent to RM10.9 billion, in line with the increase in average unit value (+16.0%). Meanwhile, a decrease was noted in import volume (-3.2%); and
- Machinery & equipment specialized for particular industries & parts which accounted for 2.3 per cent of total imports, increased by RM968.7 million or 61.1 per cent to RM2.6 billion.

6. Imports for End Use & Broad Economic Categories (BEC) Classification

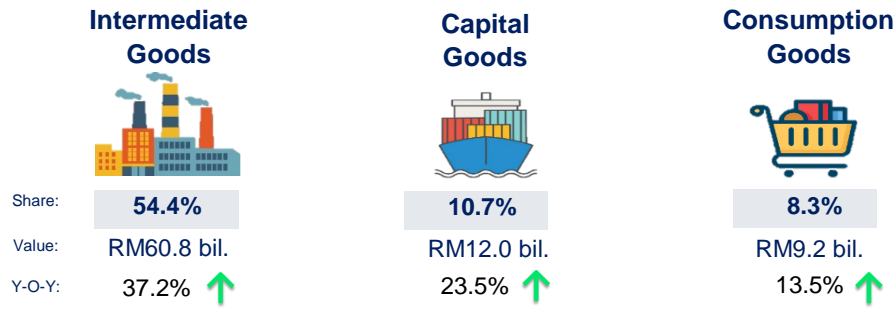
Total imports in June 2024 worth RM111.8 billion, an increase of 17.8 per cent, y-o-y. The three main categories of imports according to End Use which comprised 73.4 per cent of total imports were:

Intermediate goods, worth RM60.8 billion or 54.4 per cent of total imports, increased by 37.2 per cent supported by higher imports of parts of accessories of capital goods (except transport equipment) (+RM10.5 billion, +130.9%) and industrial supplies, n.e.s., processed (+RM2.2 billion, +11.5%).

Capital goods, amounting to RM12.0 billion (10.7% of total imports) increased by 23.5 per cent, contributed from higher imports of capital goods (except transport equipment) of RM2.0 billion or 22.2 per cent.

Consumption goods, amounting to RM9.2 billion (8.3% of total imports), recorded an increase of 13.5 per cent. It was supported by higher imports of food & beverages, process, mainly for household consumption (+RM429.8 million, +16.8%) durables goods (+RM346.9 million, +30.2%).
